Payment Options

A completed, signed, tuition agreement and registration fee of \$50 must be on file for each enrolled student. First tuition and registration fees are due and payable on or before August 15.

We offer three payment options. They are as follows. Please check one.

1. _____ ***One-payment plan.*** Payment in full on or before August 15. A 1.5% discount will be applied if tuition is paid in full by this date.
2. _____ ***Two-payment plan.*** First payment due on or before August 15 and second payment due the first day of school after Christmas break.
3. _____ ***Monthly-payments plan.*** First payment due on or before August 15. Payments two through ten (September through May) are due on the 15th of each month.

Preschool Tuition Collection Policies

- A. Students will not be admitted on the first day of school unless the August payment has been made by the family. Outstanding balances will not be carried over from one year to the next. All payments for the current school year must be made by May 15 of the current school year.
- B. If tuition payments have not been received within 10 business days of the payment due date as determined by the payment plan, a late fee of \$5.00 per week will be assessed until the payment has been made
- C. If payments are not received by the school on or before the due date, the following actions will take place:

<i>Actions Taken By the School for Non-Payment of Tuition</i>	
<i>1st Reminder</i>	<i>Family will receive notification from the school of non-payment 2 business days after the missed due date.</i>
<i>2nd Reminder</i>	<i>Family will receive written notification from the school Business Manager of non-payment 10 business days after the missed due date. Late fees will be assessed.</i>
<i>3rd Reminder</i>	<i>Family will receive written notification and a phone call from a Total Board of Education officer of non-payment 30 business days after the missed due date to discuss and make tuition payment arrangements. Late fees continue to be assessed.</i>
<i>4th Reminder</i>	<i>If payment has not been received within 45 business days after the missed due date, the matter will be referred to an attorney for small claims court collection. The student will be suspended from school until the account is current.</i>

Mandatory Fundraising Agreement

Families with students enrolled in both preschool and the elementary program will have a fundraising obligation equal to that of the elementary program.

All preschool program families must work a minimum 10 hours for fundraising or pay \$250.00 per student.
